ELEGANT real estate Privacy Policy

This privacy policy explains how ELEGANT real estate (hereinafter: "Elegant") processes your personal data. Elegant takes care of the protection of your personal data and their processing in accordance with the applicable regulations on the protection of personal data, especially the General Data Protection Regulation and the Law on the Implementation of the General Data Protection Regulation.

ELEGANT realty estate Dubrava near Tisno, Vlašići 43 is the manager of the processing of your personal data.

1. Purposes for which we process personal data

We process your personal data because legal regulations require us to take certain actions, i.e. because the processing is necessary for the execution of a contract, or in order to take actions before concluding a contract or based on our legitimate interests, except when these interests are stronger interests or the fundamental rights and freedoms of individuals who require the protection of personal data.

If we cannot process personal data based on the stated legal grounds, we will ask for your consent. If the processing is based on your consent, you have the right to withdraw your consent at any time. The withdrawal of consent must be notified to the controller by e-mail: Such withdrawal will not affect the legality of processing based on consent before its withdrawal.

We process your personal data when it is necessary to conclude and fulfill the rights and obligations arising from the mediation contract, when you send us an inquiry and when you use our website. We generally collect personal data directly from you.

2. Categories of personal data

When you conclude a contract with us, or when you contact us or visit our website, we collect the following personal data: name and surname, address, ID number; contact information (e-mail, telephone); IP address, etc.

3. Your rights

Your rights are as follows:

Right of access: You have the right to receive confirmation from us as to whether your personal data is being processed, and if such personal data is being processed, access to the personal data. Access information includes - among other things - the purposes of the processing, the categories of personal data in question, the recipients or categories of recipients to whom the personal data has been or will be disclosed. However, this is not an absolute right and the interests of other individuals may limit your right of access.

You have the right to receive a copy of the personal data being processed. For further copies requested by you, we may charge a reasonable fee based on administrative costs.

Right to rectification: You have the right to obtain from us the correction of your inaccurate personal data. Taking into account the purposes of the processing, you have the right to supplement incomplete personal data, including by providing an additional statement.

Right to deletion ("right to be forgotten"): Under certain conditions, you have the right to obtain from us the deletion of your personal data and we are obliged to delete such personal data.

Right to restriction of processing: Under certain conditions, you have the right to obtain from us the restriction of processing of your personal data. In this case, the corresponding data will be marked and can only be processed for specific purposes.

Right to object: Under certain conditions, you have the right to object at any time to the processing

of your personal data, for reasons related to your specific situation or when personal data is processed for the purpose of direct marketing, and you can ask us to stop processing your personal data.

Right to data portability: Under certain conditions, you have the right to receive the personal data relating to you that you have provided to us in a structured, commonly usable and machine-readable format and you have the right to transfer that data to another controller, without our interference. If you are not satisfied with how we process your personal data, you can contact the Personal Data Protection Agency.

4. Storage of personal data

We store the personal data we collect about you in a secure environment. Your personal information is protected from unauthorized access, disclosure, use, alteration or destruction by any organization or individual.

The collected data will be stored only as long as it is necessary for the above purposes.

Your personal data will not be stored in a form that allows you to be identified longer than we consider necessary to achieve the purpose for which it was collected or processed, i.e. in the time period prescribed by the law or regulation that obliges us to store data.

If you have given us your consent, we will process your personal data until you withdraw your consent.

In case you declare a well-founded objection to the processing of personal data based on a legitimate interest, we will not process your personal data in the future.

Furthermore, if judicial, administrative or extrajudicial proceedings have been initiated, personal data may be stored until the end of such proceedings, including the possible period for filing legal remedies.

5. Recipients of personal data

It is important to note that your personal data mwe will give it to our trusted partners who maintain our IT system or provide bookkeeping services. The mentioned service providers are obliged, according to the relevant contracts, to use the data entrusted to them only in accordance with our guidelines and exclusively for the purpose that we have strictly determined. We also oblige them to adequately protect your data and to consider it a business secret.

6. Cookies

A cookie is a small text file containing an identifier (string of letters and numbers) that a web server sends to a web browser and stores it in the browser. The identifier is then sent back to the server each time the browser requests a page from the server. Cookies are used to enable more efficient use of websites and provide information to the owner of the website. Cookies make it possible to distinguish between users, which allows users to have a positive experience on the website. ELEGANT uses services provided by Google LLC and its affiliates, including YouTube, Android, and services provided on third-party websites, such as advertising services.

This Privacy Policy does not apply to services that have separate privacy policies, however ELEGANT is obliged to inform respondents about the data collected by Google LLC (hereinafter: Google) when providing its services to other legal and natural persons.

The information Google collects and how it uses it depends on your use of Google services and how you manage your privacy controls. Also, the information Google collects includes unique identifiers, browser type and settings, device type and settings, operating system, mobile network information that includes carrier name and phone number, and application version number.

In addition, Google collects data about the interaction of applications, browsers and devices with Google services, including IP address, crash reports, system activity, and the date, time and referral URL of the user's request.

Google also collects data when a Google service on your device contacts Google servers (for example, when you install an application from the Play Store or when the service checks whether automatic updates are available).

If you use an Android device with Google applications, your device periodically contacts Google servers to provide device information and connect to our services. This includes information such as device type, carrier name, crash reports and apps you have installed.
